About 120 women participants were participated in the programme. The inaugural function of the outreach programme was held at 11.00 hr. Sharp. Smt. L. Chitra Devi (President Nachou Maning Meirapaibi Lup); Th. Prenmlata (Asst. Director, Human Rights Law Network); Dr. S. Bhogenrda Singh, (Advisor, Organization for Social Care and Research, Imphal West, Manipur); Dr. L. Muhindro (Advisor, Social Welfare and Development Centre, Imphal West, Manipur); Dr. W. Kunjarani Chanu, Director, Women's Studies Centre, SKWC, was graced as chief guest, guests of honour and president respectively.

Childlessness may be voluntary or involuntary. The concept childless may indeed, also be used for couples who do not want to have children, or are postponing childbirth, as is a frequent phenomenon in the West. However in poor-resource countries voluntary childlessness is rarely found, and if so, mostly in the upper classes. This article is focused on poor-resource areas and developing countries where most of the world population and also most of the childless population is found. I will analyse the situation of involuntary childlessness first by looking on the individual level, than the national level and finally the international level.

**Dr. S. Bhogendra** spoke on *Domestic Violence in Manipur: Traditional culture and custom*. He argued that in Manipur too, discriminatory customary laws and practices are strictly adhered to in many areas. In some communities these laws sanction polygamy and child marriage; in others, land, property rights and custody of children are given only to the males. In addition, women are debarred from taking part in political decision making. Besides, the inherent gender biases of the traditional systems, greater contact and exposure to other cultures have also resulted in acculturation and dilution of some of the positive and women friendly aspects of the indigenous cultures. For instance, in most tribes, including the Kukis if



a woman does not have a inheritance is near son. impossible. In such cases, after the death of her husband, custody of the children as well as property automatically rights are with her in-laws. Among the Meitei community in Manipur, polygamy is still practised. It is a widely held belief that polygamy was adopted by necessity rather than by design when the loss of men in the Manipuri

Burmese war was significantly high. The unequivocal need for social security gave way to elders sanctioning polygamy as a means of security and protection to women. This has however become an accepted practise now not just among the Meiteis but among the other tribal communities in the region as well.

The following case highlights the discrimination that women have to face in such situations: Binalakshmi, had been married to Arun for two years and lived in Imphal, Manipur. Right from the day of her marriage, she was taunted by her in-laws and her husband, about her looks. She said, I thought that things would change after I gave birth to a son. However they did not. Within a couple of months he got married to another woman. Whenever he would get into a fit of anger, he would beat me and lock me out of the house. Unable to bear this any longer, I finally got the courage to leave him and start living on my own. Binalakshmi has been living away from her husband for a couple of years now. She has been struggling to earn a livelihood and has recently remarried. She has been at the receiving end of a lot of criticism from family members and members of the community about being a 'bad' wife, a 'bad' mother and a 'bad' woman.

Giving the speech as Guest of Honour, **Dr. L. Muhindro** stated that what is unfortunate is that despite such vitality of our women, the brunt of all misfortune and hardship is borne by them. They have not been given their due recognition for all that they are worth which is why the women of our state still suffer from copious crimes and violence. Again, to make matters grave, most men in Manipur accept that women should be home-bound and more often than not they misinterpret freedom of women. This puts them often in a baffled and contradictory situation where on one hand they are restricted from being gregarious and free and on the other hand, they are obliged to go out and work to make both ends meet. The need of the hour is - first and foremost, unity among the womenfolk. It is of utmost importance for all the women to unanimously realize their rights and privileges in the society and state and to

encourage and support their cause. Once the women achieve this peaceful accord and form a fraternity the course to their emancipation will be a judicious path. Awareness among both men and women on the protection of rights and issues concerning women is another key remedial factor. Women alone cannot bring absolute eradication of women aggression. Men should be equally responsible pertaining to the problems concerning women. The perpetrator of violence and crime against women should be made aware of his violations and the subsequent penalties. Both men and women should be equally educated about the use and misuse of women and women should be alerted and encouraged to stand up for their rightful claims in every sphere. The next important thing is for the Government policy makers, planners, administrators and those agencies and NGOs, to formulate feasible policy measures

and programmes protect women against subjecting them mere objects. There is an urgent need to recognize women's contribution in the socio-economic and political development of our state subsequently legalize their commendable roles and give them enough room for expansion.



Adequate opportunity for women which include employment facilities, equal participation in social, political and economic sphere, fair and equal trials, and literacy programmes for women etc. With this done, we can envisage a society based on equality and mutual respect and a society with less violence and crimes against women. The formation of the Manipur State Commission for Women is a laudable initiative of the State Government to help redress grievances of women. A long cherished dream of women has materialized and women have been provided a long deprived space with the establishment of the Commission.

In the presidential speech, **Dr. W. Kunjarani Chanu** stated that the Department of Women and Child Development has taken the initiative of formalizing the concept of Gender Mainstreaming and is currently focusing on four areas for the empowerment of women, namely, Food and Nutrition Security and Employment Guarantee, Water and Sanitation, Adequate Health Facilities and Asset Base for Women (land, home, livestock etc.). Protective legislations for women's welfare such as Bill on prevention of sexual harassment of women at work place, bill to provide compulsory registration of marriages, rules under the Protection of Women from domestic violence Act, 2005, Draft Scheme for relief and rehabilitation of victims of rape, reviewing of Dowry Prohibition Act., 1961 etc. are being considered for implementation. Despite the several decrees and laws passed for the protection of women, India's record in the gender issue is utterly depressing. Women continue to suffer from the gamut of discrimination, abuse, violence and poverty, the pressure of poverty even compelled her to sell her body.



We have seen an increasing number of children being sold and women in prostitution as means of survival for their families throughout country. Increased



dependence and insecurity caused by globalization policies have also worsened the

bargai-ning capacity of women. The comodifications of women's bodies through a million images in different sections of the media (including cybersex) also lead to increased violence against women. In 2002 and 2003 there were 2,80,0398 registered cases of rape, 65,659 cases of molestation. However, the average rate of convictions in cases of violence against women is below 15 percent. (AIDW A, 2002). It confirms the fact that women are mostly affected by profound economic, political and cultural changes going on in India, during the last one and half decade or so, under the name of globalization. Manipur is not an exception from these tragedies concerning women. The protective shield for women against violence and crime present a contemptible sight. The present state of conflict situation has also compounded the problem. Increasing crime against women is an ever increasing problem in Manipur and the problem has been soaring higher and higher.

Altogether 16 research papers were presented and 86 participants were in the workshop.



In the welcoming address Dr. S. Bhogendra, Nodal Officer, AISHE & HOD, Sociology, S. Kula Women's College stated that Gender is a social construct, so, we can bring change understanding of gender by changing our mind set and socio-cultural background of our society. So, I do hope the

workshop will bring a logical discussion on the topic so that the society could enable to bring the solution of the social pathology regarding gender issues.

Introducing the theme of the workshop **Dr. W. Kunjarani Chanu**, Director, Women;s Studies Centre and Convenor of the workshop said that The issue of Gender Equality and economic empowerment has been subject matter of intense debate the social

scientist gender activities and intellectual particularly in the contest of the new emerging. However, gender roles vary greatly from one culture to another and from one social, political, and economic group to another within the same culture. Despite many Government's gender centric plans and



policies were implemented, it is still yet to achieve, gender equality in all sphere of life. In other words gender equality is intrinsically liked to sustainable development and is vital to the realization of human rights for all. Overall objective of gender equality is a society in which women and men enjoy the same opportunities rights and obligations in all spheres of life.

Giving the keynote address **L. Muhindro** (*Nodal officer: UGC University Activity Monitoring Portal, SKWC*) stated that Twenty-five years since the adoption of the Beijing Declaration and Platform for Action—a progressive roadmap for gender equality—it's time to take stock of progress and bridge the gaps that remain through bold, decisive actions. The Generation Equality campaign is bringing together people of every gender, age, ethnicity, race, religion and country, to drive actions that will create the gender-

equal world we all deserve. Together, we want to mobilize to end gender-based violence; we are calling for economic justice and rights for all; bodily autonomy, sexual and reproductive health



and rights; and feminist action for climate justice. We want technology and innovation for gender equality; and feminist leadership. Small actions can have big impacts in making this vision a reality. On International Women's Day, join Generation Equality and become part of the movement. An equal world is an enabled world. Individually, we're all responsible for our own thoughts and actions - all day, every day. We can actively choose to challenge stereotypes, fight bias, broaden perceptions, improve situations and celebrate women's achievements. The emerging global consensus is that despite some progress, real change has been agonizingly slow for the majority of women and girls in the world. Today, not a single country can claim to have achieved gender equality. Multiple obstacles remain unchanged in law and in culture. Women and girls continue to be undervalued; they work more and earn less and have fewer choices; and experience multiple forms of violence at home and in public spaces.

He also presented a paper on Women's Rights and Gender Equality: Vulnerability of Women HIV in Manipur. He asserted that HIV women largely vulnerable groups of poor family have been waiting the last breath of life. In the one sense, they can't have equal opportunity, equality before law, privacy, liberty, economy and social security and more particularly right to life and human dignity as social stigma and other forms of violence (sexual, physical, verbal) rounded against them. The question of domestic violence against women HIV has also another issue despite numerous countless issues in Manipur. HIV positive women fighting for right to life, fighting for their children, fighting against all odds are many times sexually abused and tortured by people who are considered as saviours to them. When they approach for help, they are welcome and

helped only to abuse their rights. Such hapless lamentation of HIV infected women have disclosed only when they are out of tolerance. A number of questions were germinated when it reach to the general public. HIV infected woman who approached for justice to a lawyer and had to sacrifice the chastity of a woman to the justice-provider for her only child. In another human right violation story appeared in the local newspaper, HIV women seeking ART drugs for life was reportedly lured by a person working in ART centre.

Among the invitees **M. Shakhi**, President, All Manipur Nupi Marup also made observation on this workshop.

In the closing of the inaugural function the president of the function and principal of the college, **Dr. N.**Joykumar Singh stated that I am happy to preside

# 3.6 **Advocacy:**

Not only various sensitization programmes taken up by the centre but it is also deeply concerned for the protection of women's vulnerability by setting up different information cell and units. With these initiatives, information is circulated to the localities of the college.

### 3.7 **Success Stories:**

Indeed it is an action oriented approach to the success story of this centre that the centre can establish **S. Kula Women's College, Women's Grievance and Redressal Cell (SKWC-WGRC)** on the 8<sup>th</sup> March, 2013. It is a voluntary cell within the Women's Studies Centre in the S. Kula Women's College to provide initiative role for vulnerable groups of women and children in Bishnupur District. Significantly, Dr. Ch. Jamini Devi, Former Chairperson, Manipur State Commission for Women who graced as Chief Guest of the function on International Women's Day Observance cum one day Workshop and on this auspicious day she announced the establishment of this **SKWC-WGRC**. The UGC has also approved the upgradation of the centre in the 2<sup>nd</sup> Phase w.e.f. 2016-17.

The main features of the cell may be highlighted:

*Mission:* Inspire to feel them (vulnerable women and girls) we are for you.

*Jurisdiction:* It will cover Bishnupur District only.

*Main purpose:* Dissemination of socio-legal awareness for women concerns to feel free for any complain through this SKWC-WGRC. Teaching; Research Activities; Organization of Training Programme and Outreach Programme on women and interdisciplinary activities in collaboration with other departments and academic institutions;

**Limitation:** This cell will act as a counseling cell to provide information to the concerned authorities for judicial activism and fast justice availing for the women and girl victims as a means to guide them.

Complication: Despite having different legal provisions for women, many victims can not avail justice due to various factors like unaware of the provision or lack of initiative or grievance cell, but most importantly we not only women but also man cannot claim our due rights by seeing or considering the subsequent positive and negative effects. In such way this cell cannot link up for grievances without a reasonable complaint from the concerns individual /relatives or family.

### Action-oriented:

Within 24 hours of the complain, all the members of the Cell will meet together for necessary action, whatever it may be, it will make effort to find out the way for Judicial activism.

Since the establishment of the Women's Studies Centre at the college, the centre has so far brought out several publications as an outcome of the research activities undertaken by the centre. During the first phase the college has also started a Teaching Programme of 6-month Certificate Course in Women's Studies. During the Second Phase of the centre, the college has submitted the syllabus and request for recognition for opening of Diploma Course on Women's Studies to be started w.e.f. 2020-21 under Teaching Programme. The Centre has also organized a number of Field Action Programmes on different topics related to women issues. As such, the Centre has a remarkable achievement during the first phase and current Second Phase of the establishment of the Women's Studies Centre.

The centre, as in the stage of Phase – I, its network is being developed with different women organizations, mainly Meira Paibi which is generally found in all the localities of Manipur. The centre has been trying to tie-up and to make good rapport with such organization in the neighbouring areas of the college with a hope to cope up various issues confronted by them. Besides, some state and district level NGOs who worked for women's welfare are also associated with the centre in various programmes conducted by the centre and vice – versa with a view to expand its networking.

### 4.4 **Any other**

- (c) Difficulties achievements
- (d) Leadership role

With a view to achieve its primary objective, the centre sometimes made special programme on which different victims are interviewed to find out the causal and effects of the crime meted out against them. As a follow up programme the centre has arranged informal interaction with them for bringing good rapport and for awareness of their due right as well as amicable solution. Significantly, within a short period of its inception the centre could benefit them with legal assistance by giving proper guidance and awareness activities. Moreover, the centre, from time to time discussed contemporary issues of women by organizing camera meetings and counseling programmes. In various issues, in the locality of the college, the centre has been taking initiative role for the betterment of womenfolk, for bringing mutual understanding between the confronting groups or in the victim's family.
