Conferred to Kh. Monika Devi, 1st Position- BA-HRE, 2021, Manipur University**



This Award is conferred in memory of the (Late) Laitonjam Ibotombi, Pishum Ningom Leirak, Imphal to the student of Human Rights in recognition of her academic achievement and overall performance in extracurricular activities during her student life in the college.

In the keynote - Myanmar People's Demands for Health Care Rights by COVID 19 Pandemic (Prof. HTUN, SU YIN,) The Republic of the Union of Myanmar is located in the western portion of mainland Southeast Asia and is bordered by China to the north and northeast, Laos to the east, Thailand to the southeast, the Andaman Sea and Bay of Bengal to the south and southwest, Bangladesh to the west, and India to the northwest. The outset of COVID 19 from China reached Myanmar in March 2020 and there are 18,622 total deaths among 497,700 of total confirmed cases as of October 28, 2021. According to data from ASEAN BioDispora Virtual Center, the vaccination rate is 8.4 per 100 people, which is the lowest rate among ASEAN countries. Myanmar people have suffered the first and second waves of pandemic in 2020, and third wave in August 2021.



In the plenary speech - Human Rights Issue during COVID-19 Pandemic in North East India Role of Governing Authorities and Civil Societies (Prof. Jangkhongam DOUNGEL) The term 'civil society' goes back to Aristotle phrase 'Koinonia Politike' and it evolved as a result of combination of different families and villages. Civil Society is formed by conscious people who have civic sense and who are aware of the common problem and common needs of the people. Any political system is governed by government which has three organs, namely, legislative, executive and judiciary. The Constitution of India incorporates government at three levels, such as, Union, State and Local. The North Eastern states have their own state and local governments which play significant roles during the covid-19 pandemic, and civil societies lend helping hands to the governing authorities.



Political Unrest and the Bodo Movement in Assam, North-East India (Prof. Jyotiraj Pathak) The situation of political unrest in Assam, North-East India is well known phenomenon not only among the educated, intellectuals and academicians but also among the common people of the country. It has been existence due on the one hand to the growing demand for more power and influence in the control and management of their own affairs among modern educated classes of the respective community and on the other to the systematic rejection of that demand by those who are responsible for people. The Bodos are the aboriginal inhabitants of this fertile land. They have long experience of struggle for their existence in the region.



Covid Conundrum: Global Challenges in Human Rights (Prof. Ranjita Chakraborty) Covid 19 induced pandemic has been a test for the societies globally. It has also been one of the major events throwing up multiple challenges not only for the people individually, but societies and governments individually and collectively. Guaranteeing

human rights for everyone poses a challenge for every country around the world to a differing degree. The COVID-19 crisis has exacerbated the vulnerability of the least protected in society.

Covid-19 in India: Unfolding Disaster and State Action (Prof. Shashikant Pandey) Covid-19 has been disaster of unprecedented magnitude as it has spread to around 222 countries across the globe and became the largest humanitarian crisis the world has ever witnessed. As on date (16 November, 2021)



confirmed cases were around 2, 53,640,693 and deaths were reported as 5,10,4899 across the globe. Looking at its severity, on March 11, 2020, The World Health Organization (WHO) declared Covid-19 as a pandemic.



Deconstructing the Racism of Corona Virus (Prof. Haobijam Vokendro) The corona virus pandemic that was epicentered at Wuhan in China in month of December, 2019 erupted the whole globe. WHO reports a total 1,813,811 were killed in 2020 by Covid 19 and also reported later an estimated excess of mortality of 3000000 peoples. Weal to the woes, many Mongoloid look Asians in different parts of the planet were psychologically and physically abused on the pretext that they were responsible for the menace of the virus.

Prof. Biswajit Mohapatra delivered on Women's Rights and Global Pandemic while Dr. Vikas Singh spoke on Socio-economic Rights of Poverty. Politics, Development and COVID Pandemic in North East India (Dr. N. Somorendro Singh) Development has become the focus of politics, government actions, popular imaginations and main theme of public and academic debates. Economic issues have emerged as the important issues of politics in India since the liberalization of the economy and globalization from the early 1990s. Many political leaders in India including North East swear by 'development'. Yet the basic indicators of development are still low particularly in North East India. Infrastructure development which involves huge funding and contract works has been pursuing as 'development'.



Human Rights Perspective in the Changing Role of the State amidst New Global (Dis) order (Prof. Biswanath Chakraborty) The outbreak of the COVID-19 pandemic has resulted in large scale impact on political, economic, social, administrative and cultural sphere throughout the World. The major World power has failed to give any direction or leadership in this Human

crisis. The global institutions like UNO, WHO have failed to play their role in desire manner to protect basic human rights under this crisis. Helplessness of international bodies stands exposed. Far from doing good, some of them only cover up misdeeds.

Right to Education of Tea Tribes in India Amidst COVID-19: A Study of Selected Tea Gardens from Western Duars Region (Dr. Anil Kumar Biswas) Education is a basic human right. In India 8 percent population are tribal. Educationally they are backward from others. The situation is more



pathetic within the tribal communities those who are working in tea gardens as labours. The term 'Tea Tribe' define as those who are working in tea garden as labours and residing in quarter within garden. They are mostly illiterate and living unhealthy condition in quarter within gardens. For the aims of inclusion and ensure quality education government of India has passed Right to Education act in 2009.

Human Security and Livelihood During Pandemic COVID-19: The Pakistani Experience (Debasish Nandy, Ph. D) The South Asian region has not only witnessed partition, ethnic cleansing, political violence, terrorism, and natural disasters but also pandemics like COVID-19. Since the begging of 2020, like other South Asian states, the human security of Pakistan has been threatened. For Pakistan, in contemporary times, the issue of human security, development, and livelihood is getting the spotlight in academic discourse. COVID-19 caused the rapid increase of poverty, shortage of food and health problems raised human security issues more prominently.



Pandemic and the Spectre of Surveillance State: Some Reflections (Dr Arindam Roy) The ongoing pandemic of covid 19 has posed a permanent threat to the human history in the form of an overbearing surveillance state. The commissioning of the new invasive digital surveillance mechanism by the state to put a tab on the pandemic has intruded upon the private/personal space and grossly violated the basic human rights. Subjecting individuals under systematically focused and routinized observations is the most trusted and perhaps one of the oldest tools in the hands of the authoritarian regime.

Human Rights and Global Pandemic: Issues and Responses (Dr. M. Sureshkumar) The world has endured over twenty-two months of the Covid-19 pandemic and the first and foremost priority is to save precious lives. The measures adopted by many countries to curb the spread of the virus, have a restrictive impact on people's fundamental human rights and freedoms. The pandemic has resulted in severe social and economic disruption around the world and tens of millions of people are at risk of falling into extreme poverty.



Human Rights of Women amidst the Covid-19 Pandemic: Issues and Responses (Dr. Recna Laitonjam) The global women's rights is at stake during the present Covid-19 pandemic 2020 is the 25th anniversary of the Beijing Declaration and Platform for Action the most progressive global blueprint for advancing women's rights but the Covid-19 pandemic is exacerbating pre-existing inequalities and threatening to halt or

reverse the gains of decades of collective effort for women empowerment. Gender equality is at the very heart of human rights and United Nations values.



Risks and vulnerabilities of LGBT during Covid-19 pandemic in the Global South (Dr. Nadje Al-Ali) The article addresses the gendered implications of Covid-19 in the Global South by paying attention to the intersectional pre-existing inequalities that have given rise to specific risks and vulnerabilities. It explores various aspects of the pandemic-induced 'crisis of social reproduction' that affects women as the main caregivers as well as addressing the drastic increase of various forms of gender-based violence.

Challenges of the COVID-19 pandemic in global health and sustainability: The context of Brazilian (Deisy de Freitas Lima Ventura) This article aims to reflect on the new boom in research output in the field of global health, based on two analytical elements that we consider essential. The first is the important shift in the Brazilian State's role in international relations, particularly in international forums related to health and the environment, including a significant loss of leadership in the implementation of the Sustainable Development Goals (SDG) under the 2030 Agenda.

Violation of Human Rights: A Thematic Study of Some Dalit Autobiographies by Women in English Translation (Ripunjoy Bezbaruah) Simply speaking, socio-economic freedom, access to education, right to practice an occupation of one's choice, no discrimination in any phase, right to property, protection of life and personal liberty – all consists of some of the rights of women in India. In spite of the Constitutional safeguards to the sufferings of women, they are still suffering the torments mainly because of two universal reasons: first they are 'women' and secondly the more and norms of the patriarchal society keeps them aloof.



Human Rights violation against Northeast People during COVID pandemic (Shimray Akim Lumshimla,) India is indeed a land of diversity; physically, socially, racially, where a multitude of languages and religions were born. Each and every part of our country is unique and have their own significance. It is but very unfortunate that many of our

fellow citizens still fail to understand the inherent unity that makes the very essence of our nation.

COVID-19: legal implications for critical care (N. Coghlan) The COVID-19 pandemic has caused an unprecedented challenge for the provision of critical care. Anticipating an unsustainable burden on the health service, the UK Government introduced numerous legislative measures culminating in the Coronavirus Act, which interfere with existing legislation and rights. However, the existing standards and legal frameworks relevant to critical care clinicians are not extinguished, but anticipated to adapt to a new context.

Social Policy Response to COVID-19 Pandemic: Focus on Rights of Migrant Workers in India (Gowri Dixit, Jaisuman K, Ranjini S Nadig) COVID-19 pandemic has pushed the nations to reorganize their social policies and widen their target groups due to the global health emergency and frequent lockdown. The nature of the policy response has been more protective than productive owing to welfare measures with the primary motive as the well-being of its people. India responded with a huge relief package majorly focusing on the economic welfare of the citizens, which is essentially the main feature of a social policy.

Relevance of Mahatma Gandhi views on self-sufficient Village Economy during COVID-19 Pandemic and Lockdown: A Study in the Context of Manipur. (Dr. Ruolkhumzo) Gandhi's idea of self-sufficient village economy is that every village should produce its own vital requirements. It should grow its own food crop and cotton for its cloth. Every household should own a spinning wheel and weave its own clothes. It should have its own hand-grinding, hand-pounding, oil-pressing, soap-making, etc. It should have recreation and playground for adults and children. The houses are to be build with locally available materials.



Need for Psycho- social support for children during Covid -19 pandemic situation (Dr. Koijam Sobita Devi) Children in difficult circumstances are prone to expose or engage in unacceptable behaviours. It is extremely important to address their psycho- social needs in such critical situations. Studies have shown that confining children or social distancing during the Covid-19 lockdown risks their mental health with anxiety,

frustration and depression. Parents may struggle to find ways to let the children understand about the situation which may add more frustration.

The COVID -19 Scenario and Health Issues of The Elderly Living in Old Age Homes: A Comparative Study of India and Bangladesh (Sushama Mukherjee) Background: For various socio-economic -cultural reasons the older people are compelled to seek alternative refuge in old age homes. The elderly suffering from chronic diseases more than others badly need healthcare support. Hence they prefer old age homes equipped with a medical support system.



Migrant Workers and Covid-19 Pandemic in India (Athokpam Marconi Singh) The outbreak of the COVID-19 pandemic has brought the most unprecedented challenges to the humankind at present. It has affected almost all the nations of the world. India is listed among the nations severely affected by it. The Union Government has taken up prolonged nationwide lockdown as one of the preventive measures to flatten the curve.

CWSN during Covid-19 pandemic: Challenges and supports (Mrs. Gitika Kalita and Miss Jaysree Das) One of the most affected group of people during Covid-19 pandemic is CWSN means Children With Specific Needs. This group of children is always segregated from a healthy normal life due to several reasons and the Covid-19 pandemic has made their trouble double. India is one of the few countries world over where the education of CWSN does not fall within the purview of Human Resource Development Ministry. It is generally the burden of the omnibus Ministry of Social Justice and Empowerment, the prime focus of which is rehabilitation not education.

Lessons of Covid-19 and Human Rights: Revising of India's Act East Policy towards Southeast Asia (Joyprokash Mondal & Asansol) We have got a disastrous year for Human Rights in 2020. Covid-19 pandemic has accelerated distinguished impact on Human Rights and also brought the erosion of it. Actually Covid-19 is a commercial disease and notified disaster. In this situation, under International Human Rights Law, states can limit the exercise of most Human Rights if it is necessary to protect the collective interest.



COVID Pandemic, E-Learning and Teachers' Plight (Chanambam Ritu Devi) The pandemic has affected one of the most important systems i.e., education systems. In India life has changed since March 2020 when the Government imposed nationwide lockdown forcing schools and colleges to close and instructing both teachers and

students to abandon the usual traditional classroom teaching and learning style. This resulted in the dramatical change in education, with the distinctive rise in e-learning.



COVID- 19 and Violation of Human Rights (Dr. Shamshad Ansari) The most striking feature of the concept of human rights is that it is difficult to define them and it is impossible to ignore them. Human Rights are as old as human civilization itself. Human rights are simply defined as the rights, which every human being is entitled to enjoy and which protect him. COVID

-19 created a big problem in front of human civilization. The COVID-19 pandemic unleashed a massive devastation across the world. India is one of nations which suffered more due to massive spread of virus.

Impact of Covid-19 on Child Rights (S. Chanu Shreela) Most people alive today have never seen the coronavirus (COVID-19) pandemic. All over the world, the outbreak is claiming lives and livelihoods as health system buckle, education is disrupted and families struggle to stay afloat. Children who contract COVID-19 appear to have less severe symptoms and lower mortality rates than other age groups. But they risk being among its biggest victims.



Online Education during the Pandemic: Prospects and Challenges (Dr. Thounaojam Tapasini Devi and Dr. Thajamanbi Yumkham) The entire humanity has experienced the worst affect of the deadly corona virus in the last one and half years and still continues to experience the wrath of the ongoing pandemic. One major concern during this time, besides several others is that of the future of our children’s education. The biggest challenge before the various stake holders at a point of time during the first wave of the pandemic when all the educational institutions all over the globe had to be shut down to save the millions of lives was that of thinking and creating a platform to keep the children’s education going.

Islam, Economic and Entrepreneurship of Meitei Pangal during COVID Pandemic: A Review (Md. Faizul Haque) The present paper attempts to understand the socio-economics systems and their relationships with other communities of the state. Among the Muslims, large sections of the population were found to engage in household enterprises which are economically not viable. Muslim entrepreneurs are compelled by religious laws to abstain from engaging in certain economic and financing activities, such as those involving gambling, usury, and speculation.



Covid-19 and Human Rights Violation (Saiful Sheikh) Concerning pandemic is a serious issue, every one of us need to take some common actions against the disease. The Khurkhuls is considered one of the *Ariba Meitei* ‘the old Meitei’, a Tibeto-Burman community located 16 km from Imphal, the capital of Manipur. According to the Khurkhuls, the culture of rearing silkworms is traced way back to the time when human beings and spirits used to co-exist.



The Impact of Covid-19 Pandemic on Human Rights in India: A Study (Longjam Herojit Singh) This paper examines the impact of Covid-19 Pandemic on human rights in India. Due to having an unprecedented pandemic and imposition of restrictions in the country, various movements, mobility, social interaction and commercial works were paralyzed. In order to minimize the rapid spread of pandemic, the Government imposed restrictions on the Freedom of the Citizens. Therefore, this paper identifies the issues pertaining to the human rights in India.

Dissecting Covid-19 and Women from the Prism of Beijing Declaration and Platform for the Action (Kabindra Sharma) As the year 2020 marked the 25th anniversary of the Beijing Declaration and Platform for the Action, in which representatives from 189 countries signed in an agreement to remove obstacles for women’s equal and active participation to all private/public spheres and there was galore across the globe to examine the success and achievement made in the last 25 years. Human Rights of Women During the Covid-19 Pandemic (Maibamn Donna Devi) Covid-19 affects different people in different ways but the effect is mostly prominent among the vulnerable groups, especially women. Despite the progress made in the status and position of women during the last many years, the Covid-19 pandemic had once again threatened women's rights worldwide be it in the health sector, social, political, economy or security to social protection. Incidents and evidence are increasingly reported showing that the policy of confinement leads to increased levels of domestic, sexual and gender-based violence and therefore to a heightened need of protection against this.

E-Education and Human Rights during Pandemic (Sanasam Dineshori) All children have



a right to education – a right that so many children have now been unable to fully enjoy. This was often the consequence of legitimate efforts aimed at protecting public health during this, but Human Rights watch also identified mismanaged, ill-informed, under-resourced, and even discriminatory government response, built upon structurally unsound and unequal education systems. In response, all

governments should now rise to the challenge and built better education systems that create opportunities for all children.

Impact of Covid-19 and Peoples' Livelihood (Khumanthem Romabai Devi) The world wide problem of Corona virus or Covid-19 Pandemic, which was spread out of Wuhan city of China, in late 2019 led to a dramatic loss of human life. It extends tremendous challenges to public health, food system and livelihoods. The adverse socio-economic effects of the Pandemic led to disruptions in day to day life, health care, and nutrition.



Analysis of COVID-19 Crisis Management on Education (Lourebam Christopher) The outbreak of the global Covid-19 pandemic in 2019 affected every section including education beyond boundaries worldwide. Every country imposed several restrictions to curtail the spread of the virus. India too witnessed such imposition including nationwide lockdown. This has drastically affected the education system which is the cornerstone of the country. It has stymied to conduct of proper physical classes for imparting education to the children. The paper highlights the initiatives taken up by international organizations including UNESCO, UN, World Bank, IFRC, UNICEF, and WHO to mitigate some of the problems engendered by the pandemic on education.

Impact of COVID-19 in Education and its Value in North –Eastern Region (*Dr. Lukram Ibempishak Devi*) The Novel Coronavirus is a kind of disease caused by a virus. When the International Research committee announced it as a pandemic of the world it affected a great disturbance in the academic career as a whole in the world. In the past decade Indo-Myanmar Relationships have seen several developments. According to the 2016 report, border trade between India and Myanmar stands at approximately \$50 million, up from about \$15 million in 2005-2006.

Covid-19 and Human Rights Violation (Dr. Baijayanti Bhattacharyya) Covid-19 has led to a broad range of human rights violation around the world. The spread of covid-19 has not stopped, as a result it affects continue, including human rights violation. To slow transmission of the virus, Government declared Lockdown , which restricted the freedom of movement, freedom of enjoy many others human rights and it effected people's livelihood and security, their access to health care, to food, work, as well as education.



Impact of Covid -19 and People's Livelihood (Sapam Jyoti Devi) The purpose of this paper is to evaluate the challenges of various aspects such as public health, food system and the field of work of the people globally affected by the Novel Corona Virus (COVID-19). The stresses of the COVID-19 crisis worldwide have led to devastating socio-economic disruption of people. The mental health and well being of all societies have severely been affected due to this crisis. Considering the food supply system, it has been seen that COVID-19 has an enormous impact on the whole process from the field to the consumer.

Covid-19 Pandemic and Emerging Socio-Economic & Health Crisis: An Analysis of Women Rights during Pandemic through a Gendered Lens (Soumalya Ghosh) Covid-19 Pandemic has hit hard the entire world. Accessibility basic education, health care, drinking water and sanitation are important among them. Covid-19 Induced Racial Discrimination in Global Context: A Human Rights Perspective (Bidyasagar Laitonjam) We all have come across with enough incidents in concerned with racial discrimination around the globe, among all these some of the historically dominant cases of racism are- Nazis against Jews, Whites (Europeans or Europeans

Settlers) against Blacks (African/ African American), Whites against Asian Americans, the mainland Indians against the northeasterners, etc. and the steaming case of Israel and Palestine.

Students and Stress Management: Initiative in Higher Education during COVID Pandemic (N. Satyabati Devi, L. Nandini Devi and H. Chitra Devi) This paper attempted to study different activities of Higher Educational Institutions in Manipur during COVID pandemic. Different higher education institutes had taken up extracurricular activities through online mode besides other online classes that definitely help in stress management of students.

COVID 19 Pandemic and vulnerability of Women: Socio Economic threat in Manipur (Dr I. Kunjabati Devi) Due to a serious global health emergency, the World Health Organisation (WHO) on the 11th February, 2020 has declared COVID 19 a pandemic. Till now, there is no particular vaccine for its treatment; and many researches are going on for the effective treatments which are all in trial stage. The WHO says the best effective measures to safeguard against this pandemic is to observe the standard operating procedure (SOP) such as to stay home, social distance, face mask, frequent washing of hands with hand sanitizers, soaps etc.

Ostracism and Racial Discrimination during COVID-19 Pandemic: A review on Ethnic Assertion in Northeast India (Dr. Laitonjam Muhindro) COVID-19 patients or suspected cases are being stigmatised or labelled as “corona carriers” because they face social ostracism, mental torture, and abusive behaviour in society. Although the stigma associated with pandemics has been a well-established phenomenon (Person et al., 2004), due to its contextual nature (Hebl and Dovidio, 2005), the way it unfolds might vary depending on its context finds its existence. The present ongoing situation of COVID-19 pandemic and its impact on physical and psychological health and how people interact with others are compelling enough to initiate an analytical examination of social ostracism, racism, and discrimination related to COVID-19 in general and Northeast people in particular.



Issues and Challenges of Anganwadi Centres in India during COVID Pandemic: A review (W. Lata Devi) Growth monitoring of infants for assessment of malnutrition be resumed after being suspended for four months during the lockdown, the Integrated Child Development Services (ICDS) programme commissioner has asked the administration of all districts to stop entrusting anganwadi workers with surveys and other work related to the [Covid-19](#) pandemic.

Healthcare during COVID 19 in India: Human Rights Dimensions (Dr. P. Dhaneshwari Devi) International human rights law guarantees everyone the right to the highest attainable standard of health and obligates governments to take steps to prevent threats to public health and to provide medical care to those who need it. Human rights law also recognizes that in the context of serious public health threats and public emergencies threatening the life of the nation.



Role of an Institution during COVID pandemic: Experience of Women's Studies Centre (Dr. W. Kunjarani Chanu) This paper made effort to see the activities of higher educational institutions in Manipur during COVID pandemic in relating to economic development and student support. During the COVID pandemic not only Ministry of Human Resources, now Ministry of Higher

Education, Government of India and University Grants Commission had taken up various programme in relating to COVID.

Impact of COVID 19 on Kauna Craftsman: A Case Study of Khangabok Village, Manipur (Loukrakpam Martina) The pandemic and subsequent lockdown have had a devastating impact on the Indian economy with rising unemployment, lower GDP, financial crisis, price hike of essential commodity etc. In this regards, Handicraft sector is one of the most affecting sectors as most of the products are grouped into "non-essential" therefore their situation is getting less visibility even though the artisans and weavers are the third largest segment among the poor in the country.



Covid-19 & right to health with reference to the state, Manipur (Dr. Hijam Binota Devi) Covid-19 is a virus that cause severe respiratory illness in human beings. This virus is reported to be originated from the city of Wuhan seafood Wholesale Market, China in November, 2019 and on 30 January, the WHO declared the COVID-19 outbreak a Public Health Emergency of International Concern (PHEIC). The WHO announced Covid-19 as a pandemic disease on 11 March 2020. This disease have infected more than 196,910,000 people in the world; over 4,850,000 person have died due to Covid-19 infection.

Health and socio economic impact of covid 19 Outbreak: Gendered Perspectives (A Devidas Sharma) The COVID-19 outbreak is impacting societies around the world in an unprecedented manner. However, not everyone, in every place, will be affected in the same way. Considering how the pandemic affects particular groups will help raise the effectiveness of containment efforts and minimize the potential negative impacts. Gendered Impacts of Covid -19 and e-education in response to covid 19 outbreak come to the centre stage and many studies and research are done on this aspects.

Pandemic and Women's Empowerment: A Study of Manipuri Women in Unorganized Sector (Dr. Koijam Dhaneshwori Devi & Dr. Ngangom Liklaileima Devi) Women's empowerment begins with and is supported by economic independence. Promoting gender equality has been a key priority of the Government and is also played a focal role in the sustainable Goals (SDGs) Agenda, 2030. Globally more than 60 % of the world employed population engaged in informal sector for their livelihood. But in India

around 92% of its population consists of unorganized workers. Women working in the unorganized sector deserve a separate mention as they are much marginalized than men.



Psycho-social Support and Behavioural Change: Impact of COVID 19 (Dr. S. Bhogendra Singh) It is learnt by all that the countrywide school closures, factories and industries shut, company and business enterprises hit, college and university students in bleak about their career, mass exodus of migrant workers with no hope for

return to work, unemployment rate shoots up, small traders and daily wage labourers are severely affected and stranded passengers and students. This prolonged home confinement leaves negative effects on physical and mental health of children, adults and the elderly.

Right to Food and COVID Pandemic: Initiative of Government and CBOs, Individuals (A. Surjit Singh) More so, the pandemic has undermined the profession's historical value commitment to social justice and human rights while overturning our insistence on the importance of human relationships. The purpose of this paper is to explicate the initiative role of the civil society organizations and viz- a viz role of government to provide food for survival during COVID pandemic. We almost heart about the free rice to all the citizens of India by the government.



Experience of Anganwadi Centres during COVID-19 Pandemic: A Perspective (Meena Akoijam) Anganwadi Centres are the main body of ICDS (Integrated Child Development Services). It is India's response to the challenge of meeting and holistic need of the child. The ICDS is one of the world's largest and most unique

outreach programs for early childhood care and development. ICDS services are provided through a vast network of ICDS Centres known as Anganwadi. It is a package of six services i.e., supplementary nutrition, immunization, health check-up, referral services, nutrition and health services.

this regard correct information is indispensable to dispel uncertainty, fear, and violation of human rights by the State forces.


